The Revenue Commissioner bills annually around October 1<sup>st</sup>. Payment is due BY December 31<sup>st</sup> each year and is considered late January 1<sup>st</sup> each year. Since you are requesting financing with us, we as your lien holder, have a superior financial interest in ensuring your taxes are paid to protect our security interest, preventing the Revenue Commissioner from selling the property for back taxes.
